

EUC2007 Terms and Conditions of Participation

In registering for EUC2007 you have agreed to the following Agreement.

1) I, the participant, in consideration of, and as a condition of acceptance of my entry in EUC2007 (the Event) for myself, my heirs, executors and/or administrators, hereby waive all and any claims, rights or causes of action which I might otherwise have arising out of my death or injury, damage or loss of any description whatsoever I may suffer or sustain in the course of, or consequent upon my entry or participation in the Event.

2) This waiver, release and discharge shall be (and operate separately) in favour of all persons, corporations and bodies involved, or otherwise engaged in promotion or staging the Event and each of their servants, agents, representatives and officers.

3) I acknowledge that I enter the Event at my own risk and that I have sought, or will seek, medical clearance prior to participating in the Event.

4) I hereby give my full consent to EUC2007's organisers to copyright and/or publish any and all photographs, videotapes and/or film in which I appear while attending EUC2007. I further agree that the organisers may transfer, use or cause to be used, these photographs, videotapes, or films for any exhibitions, public displays, publications, art and advertising purposes, and television programs without limitations or reservations.

5) EUC2007's organisers have the right to prohibit unauthorised commercial photography, video and audio recordings at the Event, as well as the right to prohibit the unauthorised publication, reproduction or distribution of such recordings. Based upon these rights any individuals wishing to take photographs or make audio or video recordings for commercial purposes at the Events must obtain prior authorisation.

6) I agree to abide by the rules and regulations for the Event and conform to them (for participants under the age of 18, a parent or guardian must sign on behalf of the participant.) Full details on the event rules and regulations can be found at www.euc2007.org.

7) If any portion of this Agreement is invalid and/or is declared to be invalid by a Court of Law, the balance of the Agreement shall continue in full force and effect.

8) Attending EUC2007 signifies that I have read and voluntarily agree to this release and waiver of liability and indemnity Agreement and further agree that no oral representations, statements, or inducements apart from the foregoing written Agreement have been made. I acknowledge that I have read the foregoing paragraphs and am completely aware of the potential dangers incident to engaging in the Event, and fully aware of the legal consequences of agreeing to the within instrument. Participants' action of attending EUC2007 events signifies agreement to this waiver of liability.

PRIVACY STATEMENT

1. "Personal Data" is any data that identifies you. We will deal with your Personal Data in compliance with the current UK data protection legislation.

2. A limited amount of your Personal Data will be publicly available on the EUC2007 website in the form of Team Rosters and Player Profiles.

3. Any Personal Data such as email addresses or phone numbers will only be used by us (and any other body closely linked with the EUC2007 organisation such as the European Flying Disc Federation) for the purposes of organising and managing the Event.

However, this Data will only be disclosed on an anonymous and aggregated basis and not in a way in which you will be identified.
